# DPFJ, DSA and JDTF released joint proposal 'Policy Proposal for Promoting the Data Governance Strategy'

DPFJ (Digital Policy Forum Japan, Representative Director: Yasuhiko Taniwaki) has formulated and published the proposal 'Policy Proposal for Promoting the Data Governance Strategy" in collaboration with DSA (Data Society Alliance, Representative Director: Noriaki Okui) and JDTF (JAPAN Digital Trust Forum, Chairman: Satoru Tezuka).

In this proposal, we have identified three key issues facing Japan today: the revitalization of local communities, the creation of new industries, and the strengthening of economic security. We have identified the strategic use of data as important in addressing these issues, and have proposed the following measures: (1) Building a Data Integration Platform across Business Categories and Organizations, (2) Establishment of the "Data Circulation Promotion Law", (3) Developing a Trust Service Environment, (4) Promotion of R&D for Data Collaboration, (5) Promotion of Secure Government Cloud Usage, (6) Development of International Data Flow Framework, (7) Promotion of International Data Utilization Project, (8) Promotion of International Standardization

The proposal also recommends that the government form a specialized organization to promote data governance strategies, as well as establish a new public-private council, to ensure steady progress.

The DPFJ will continue to work with related organizations such as the DSA and the JDTF to promote digital policies aimed at realizing a data-driven society.
